- 7. Open flame appliances are not allowed within the tent structure.
- 8. NO drug or Alcohol-related items (t-shirts, buttons, or posters with advertising or slogans) allowed. All work MUST be appropriate for family viewing during daytime events. Displays may be all-ages after 8 p.m.
